 All students must be 18 years old and have a high school diploma, GED or an equivalent.  
 All male apprentices between 18-26 years old must be registered with Selective Service according to the Senate Bill/Law 03-255.  
 Apprentices not registered or not exempt will not be qualified to attend.  
 All Classes have limited capacity.
